Mayor Lilburn opened the public hearing.

City Attorney Marroquin stated the Building Code Amendments are typically updated every three years. The process for considering this type of ordinance differs slightly from our usual procedures. Normally, if an ordinance requires a public hearing, it is conducted at the first reading when the ordinance is introduced. In this case, the City Council will be conducting the first reading today. Building Official Wirz will give his presentation regarding the ordinance, and there will be an opportunity for questions. Following the presentation, a motion will be requested to schedule a public hearing for the proposed ordinance at the November 12, 2025, City Council Regular meeting. This procedure aligns with the requirements outlined in the government code for adopting these types of ordinances, and therefore differs from our standard process.

Building Official Wirz stated the State of California adopts, amends, and publishes the model building codes on a three-year cycle. Earlier this year, the State approved the 2025 California Building Code Standards, which become effective January 1, 2026. The City is required to adopt these codes and may incorporate substantive amendments that are more restrictive and tailored to our local conditions, including climatic, geological, and topographical considerations. As part of this cycle, the State has introduced the 2025 California Wildland Urban Interface (WUI) Codes. These codes provide additional guidance and measures to mitigate risks in high fire hazard areas, aiming to reduce the potential loss of life and property due to wildfires. Additionally, California passed Assembly Bill 130 earlier this year, which imposes a statewide freeze on residential building code updates until June 1, 2031. This legislation prohibits both state and local agencies from adopting new standards for residential buildings unless necessary for emergency wildfire mitigation. The purpose of this six-year moratorium is to facilitate permit processing for developers and to support the ongoing efforts to address the state's housing affordability challenges. Any modifications to the residential building codes during this period must be substantially equivalent to the amendments implemented by the City prior to September 30, 2025. The 2025 codes are to be adopted by reference, with amendments outlined in the proposed ordinance Attachment "A". The supporting findings and justifications are included in Resolution Attachment "B".

Staff recommends City Council waive the full reading of the ordinance and introduce it by title only. Additionally, staff proposes scheduling a public hearing for the proposed adoption of the ordinance at the November 12, 2025, City Council regular meeting, and requests authorization to provide notice of this public hearing.

Mayor Lilburn asked if there were any questions from the public? Seeing none, she closed the public hearing and brought it back to City Council for deliberation.

Councilmember Timmer stated, in a previous meeting, City Council adopted new fire hazard zones. Are those new zones incorporated into the ordinance implemented today? Building Official Wirz stated no. The high fire hazard zones are designated by the state, and these designations are incorporated into the building code updates at the state level. When reviewing the WUI codes, the state categorizes zones into tiers, which correspond to our local ordinances for high, medium, and low fire hazard areas.

Councilmember Timmer inquired whether the updated fire code mandates the inclusion of residential fire sprinklers.

Building Official Wirz stated all new buildings constructed since 2013 have been mandated to incorporate residential fire sprinkler systems. Additionally, the fire codes include provisions in the appendices that require fire flow test, and may necessitate supplementary sprinkler requirements as part of mitigation measures.

A MOTION was made by Councilmember Saldana, seconded by Councilmember Timmer to:

- 1) Waive full reading and introduce Ordinance No. 477, as read by title only; and
- 2) Schedule a public hearing on the proposed adoption of Ordinance No. 477 for the November 12, 2025, City Council meeting, and direct staff to provide notice of said public hearing. Motion carried on a roll call vote, 3-0, with Mayor Pro Tem McCallon and Councilmember Hogan being absent for this item.

 - 2) Adopt the Budget and include a banner to be placed on the west side of the city.

18. Consideration of Proposals for the City's Tow Rotation List Program Beginning January 1, 2026 and ending December 31, 2027

Community Development Director Mainez gave a brief review of the staff report.

A MOTION was made by Councilmember Timmer, seconded by Councilmember Saldana to:

- 1) Review the proposals from the Tow Operators and award two (2) year agreements to participate in the City's Tow Rotation Program with only six (6) contracts; and
- 2) Authorize the Mayor to execute the associated agreements. Motion carried, 3-0 with Mayor Pro Tem McCallon and Councilmember Hogan being absent for this item.

19. Appoint One (1) Member of the Public to the Community Trails Committee

The floor was opened for nominations.

Mayor Lilburn nominated applicant, Joey Martin.

Hearing no other nominations, City Clerk Muñoz closed the floor for nominations.

City Council unanimously appointed applicant Joey Martin.

20. City Manager Report and Comments (Work Program, Regional/Legislative/Development Issues, Subcommittees, etc.)

City Manager Zamano stated the Highland Sheriff's Department for the month of September received 2,728 calls for service, made 319 reports, 152 arrests, issued 66 citations, conducted 196 traffic enforcement stops, responded to 50 traffic collisions, 17 transient calls, and 20 towed vehicles.

The Highland Fire Department for the month of September received 630 calls for service, some of which included: 482 medical aids, 29 traffic collisions, 9 structure fires, 9 vegetation fires, 18 other fires, 8 vehicle fires and 33 public service assistance.

The Administrative Services/Finance Department for the month of September issued 44 business licenses, renewed 266 business licenses, issued 112 dog licenses, 52 yard sale permits, and 204 account payable checks.

Human Resources is currently recruiting a Maintenance Worker I for the Public Works Department following the retirement of Jack Avon in September 2025. Anyone interested can apply on the city website.

Public Works announced the Natural Parkland Trail Project north of Base line at Brookwood Lane is currently under construction. Please note that the trail is temporarily closed to the public. The project is scheduled for completion and reopening in the first quarter of 2026, with new improvements.

The 9th Street Sidewalk Gap Closure Project and the 2025 Arterial Resurfacing Project are completed. Final inspections are currently in progress, and notices of completion will be presented at an upcoming City Council meeting.

California's rainy season typically begins on October 1 and lasts through April 4. This serves as a reminder to inform the public of relevant safety measures. City departments, including Fire, Police, and Public Works, will closely monitor key areas during significant storm forecasts and are prepared to respond to emergencies. Sandbags are available at all Fire Stations and City Hall. Self-serve sand and sandbags are located at Fire Station #2 and City Hall. East Valley Water District (EVWD) offices, including their headquarters on 31111 Greenspot Road and the Sterling Natural Resources Center (SNRC) at Fifth Street and Del Rosa Drive, offer free sandbags and sand to residents. Residents are encouraged to register for the Smart 911 Telephone Emergency Notification System (TENS) to receive important alerts and updates from the San Bernardino County Emergency Management team. Further details are available on the city's website and social media.

On October 8, the San Bernardino County Transportation Authority (SBCTA) recommended that the Board approve the Transportation Development Act (TDA) Article 3 funding of \$357,700 to the City of Highland to address sidewalk gaps providing access to Highland Grove Elementary, Beattie Middle School, and the U.S. Post Office. This project includes the installation of sidewalks on the east side of Boulder Avenue from Eucalyptus Avenue to Webster Street, as well as on the west side of Webster Street from

Boulder Avenue to Eucalyptus Avenue. The project has a local match of \$372,300, bringing the total estimated cost to \$730,000.

On October 10, the City received notification of a federal grant award totaling \$625,000 through the 2025 COPS Hiring Program, from the U.S. Department of Justice Office of Community Oriented Policing Services. This grant aims to support the recruitment of full-time law enforcement officers dedicated to community policing initiatives. It will fund up to \$125,000 for each of the five new deputies recently added under the sheriff's contract, covering a portion of their salaries and fringe benefits over a three-year period. A 25% local match is required, and all officers hired through this grant must be retained for at least one year beyond the end of federal funding. The program provides a five-year window to complete the recruitment, hiring, and full implementation of these positions.

October 23 through October 31 will be Red Ribbon Week. Residents are encouraged to wear red to initiate the week and promote a drug-free community.

For the month of September, Burrtec completed 281 illegal dumping work orders.

The Community Development Department announced grading activities are underway by Alliance Residential Company in the northern section of Greenspot Village and the Marketplace Specific Plan, located north of Costco, to support the construction of 294 multi-family residential market rate units.

The new Vim and Vigor Gym is making progress on the interior and exterior renovations at the former Esporta Fitness facility on Greenspot Road. A temporary trailer is available for membership sign-ups, with the official opening expected to take place in December.

Quick Quack Car Wash will have an official ribbon cutting ceremony scheduled for October 21, 2025, at 4:30 p.m.

Dutch Bros Coffee is now open. They are located within Highland Village Plaza at the intersection of Base Line and Boulder Avenue.
